

# Flame of Excellence Honoree Wilson W. Wyatt, Sr.

Wilson Watkins Wyatt, Sr. (1905-1996) served as Mayor of Louisville from 1941 to 1945 and as the 43rd Lieutenant Governor of Kentucky from 1959 to 1963. He served in the Cabinet of President Harry S. Truman and was a Special Envoy to Indonesia in the 1960s. Throughout the years, Wyatt always returned to the law firm he had formed in the mid-1940s, Wyatt, Tarrant & Combs. He and his wife, Anne, were generous philanthropists.

The word most often used to describe Wilson W. Wyatt is statesman – extremely intelligent, kind, articulate, visionary, positive attitude, true gentleman, motivational, realistic, and incredible inspiration to others. Mr. Wyatt shared a keen interest in the next generation, which led to his extraordinary support for the development of Leadership Kentucky in the 1980s. He is the spark that lit the Flame!

### "Improve Your State."

Leadership Kentucky, offering four unique programs across the Commonwealth, creates a network of engaged leaders who develop alliances and influence positive change in their communities and throughout the state.



Improve Your State.

LEADERSHIP KENTUCKY joins together a selected group of <u>established</u>, <u>diverse leaders</u> with a variety of career accomplishments and volunteer activities, to gain insight into complex issues facing the state. In a series of seven monthly, three-day sessions held at various locations throughout the state, participants meet with Kentucky leaders and explore the state's resources and opportunities.

BRIGHT KENTUCKY is designed especially for residents of the 54 Kentucky counties of the Appalachian Regional Commission (ARC) and builds the capacity of <u>next-generation leaders</u> (average age 21-40) to innovate, collaborate, and advance community and economic development in a series of five monthly, three-day sessions.





ELEVATE KENTUCKY offers <u>young professionals</u> (average age 25-35) in-depth personal and professional development while fostering a better understanding of challenges facing our Commonwealth in a series of three monthly, three-day sessions. Participants return to their companies with increased skills, knowledge, perspective, and a new statewide professional network and are better prepared to ELEVATE Kentucky.

NEW EXECUTIVES TO KENTUCKY highlights signature Kentucky experiences and thought-provoking discussions about exciting opportunities in our Commonwealth. The one-day complimentary program is designed for <u>senior level executives</u> who have transferred into the state during the last two to three years. Participants connect with Kentucky's best minds in government, business, and industry.





# The History of Leadership Kentucky

For 40 years, Leadership Kentucky has played a vital role in building leadership capacity in the Commonwealth through insightful experiences and thought-provoking discussion. The original goal of developing a statewide network of informed and committed leaders has now expanded to four unique programs including Leadership Kentucky, ELEVATE, BRIGHT, and New Executives to Kentucky. Leadership Kentucky has enriched the lives of nearly 2,500 graduates, who are dedicated to building a greater Kentucky.

In the late 70's and early 80's, leadership development programs were being established across the state and nation. Fewer than five states had a statewide leadership program at the time, but in Kentucky, Leadership Louisville, Lexington, and Owensboro were all having great success and bringing renewed energy and commitment to their communities.

Galvanized by what they had experienced in their own cities, young and civic-minded Dave Adkisson, Bob Babbage, Laura Babbage, and Joan Riehm, conceived of a program that would bring a diverse network of leaders together to focus on state

issues and provide an opportunity for deeper understanding and engagement in the shaping of Kentucky's future. These founders knew the person chosen to serve as chairman of the organization needed to be someone well-known, deeply-respected, and of the highest level of integrity, so they shared their vision with Wilson W. Wyatt, a prominent lawyer in Louisville, with Wyatt, Tarrant and Combs, who had served as the former Mayor of Louisville and Lt. Governor of Kentucky, and requested his commitment to lead as the founding chairman of "Leadership Kentucky."

Wyatt agreed to serve if certain criteria were met: the program must have a statewide sponsoring organization and adequate funding secured to successfully commence the initiative. Joan Riehm arranged a meeting with Kentucky Chamber of Commerce Chairman, John L. G. Richards, to seek sponsorship for the non-profit educational program. Although it was during a period of change, the Chamber's new Executive Director, Jim Wiseman, along with Chairman Richards, gave full backing for the initiative and pledged administrative support. Subsequently, the Kentucky Chamber of Commerce Board of Directors voted to serve as the sponsoring organization. Leadership Kentucky was formally incorporated on January 18, 1984. While Leadership Kentucky is a separate 501(c)3 organization, the Kentucky Chamber has remained supportive throughout Leadership Kentucky's history.

Work continued in recruiting Leadership Kentucky Executive Committee members. Invitations were extended on behalf of Wyatt and all asked agreed to serve. The inaugural Executive Committee members, in addition to Chairman Wilson W. Wyatt, Sr. included Vice Chairman Robert F. Stephens; Secretary, Albert G. Clay; Treasurer, William B. Sturgill; Lawrence F. Forgy; Frank P. Justice; Nana Lampton; John L.G. Richards; Albert P. Smith; and James M. Wiseman, all of whom were fully engaged. Jim Wiseman committed to oversee the effort and John Richards offered his expertise to lead the necessary fundraising strategy. Julie Hahn served as the Program Director for the first two years.

The James Graham Brown Foundation provided the \$50,000 initial funding to launch the initiative. Treasurer Bill Sturgill single-handedly raised the other funds needed for the program year, which was a miraculous effort. With both requirements met, Leadership Kentucky would become a reality. A roster of top



business and civic leaders from across the Commonwealth were recruited by Wilson Wyatt to be stewards of the new organization. The Steering Committee, led by Joan Riehm and Jim Wiseman, was expanded to include Bob and Laura Babbage as well as additional representatives from across the state to assist in building out the framework of the program along with Julie Hahn. The volunteer committee met on weekends and fleshed out the details addressing questions such as topics to be covered, number of sessions, how many days for a session, session locations, application process, tuition cost and so forth. Tuition for the 1985 class was \$500 and total budget for the year was \$79,500!

One of the first statewide leadership programs established in the nation, Leadership Kentucky has served as an important platform bringing leaders together to focus on issues important to the state such as education, health and human services, media, government, economic development, arts, environment, law, and social justice. Additionally, participants continue to visit the various regions of the state experiencing firsthand the unique heritage and culture that lies across the Commonwealth. Local newspapers, chambers of commerce, and leadership programs were a huge help in publicizing the new program. From the beginning, communities have graciously opened their doors hosting Leadership Kentucky and providing rich and memorable experiences.

Founders believed diversity of the backgrounds and geographic locations of the class members would add to a richer experience. Therefore, it was important the classes be composed of individuals with diverse backgrounds and that they reside all

throughout the state. This diversity has proven to be the number one reason for the ongoing success of Leadership Kentucky and remains a pillar of the organization as its alumni hail from all geographic, occupational, ethnic, and economic backgrounds, serving in vital roles across the state such as leading business and industry, health organizations, education, non-profits, arts institutions, law and justice, government agencies, and more. Kentucky's future is dependent on the vision and dedication of its leaders. To that end, Leadership Kentucky remains committed to connecting and inspiring the Commonwealth's current and future leaders, unleashing Kentucky's full potential.

Leadership Kentucky was (and is) bigger and greater than any one person or organization... it is aspirational for the Commonwealth and for those involved. The program offers hope and opportunity to pull the state together and forward from shared ideals and values. The fact that John Ed Pearce, Barry Bingham, Sr., and Wilson Wyatt, Sr. all came to Cumberland Falls for the first opening retreat demonstrated the commitment from the beginning.

As Jim Wiseman often says, "Leadership Kentucky has remained true in its purpose while growing, expanding, and evolving, with unceasing support from board members, alumni, and staff. It's simply
